## Review Atmus specifications

### **Supported Documents**

#### **Atmus projects specifics:**

- Tax data is accepted at the header/summary level or at the line item level of the invoice.
- Shipping data is accepted at the header/summary level or at the line item level

#### **Supported:**

- Purchase order confirmations Apply against a whole PO or line items
- Advance shipments Notices Apply against PO when items are shipped
- Detail Invoices Apply against a single purchase order referencing a line item
- Partial Invoices Apply against specific line items from a single purchase order
- Service Entry Sheets Apply against a single purchase order referencing a line item



## Review Atmus specifications

### **NOT Supported Documents**

#### **Not supported:**

- Summary or Consolidated Invoices: Apply against multiple purchase orders; not accepted by Atmus
- Invoicing for Purchasing Cards (P-Cards) An invoice for an order placed using a purchasing card; not accepted by Atmus
- Duplicate Invoices: A new and unique invoice number must be provided for each invoice; Atmus will reject duplicate invoice numbers unless resubmitting a corrected invoice that previously had a failed status on Ariba Network
- Duplicate Invoices: A new and unique invoice number must be provided for each invoice; Atmus will reject duplicate invoice numbers unless resubmitting a corrected invoice that previously had a failed status on Ariba Network
- Paper Invoices: Atmus requires invoices to be submitted electronically through Ariba Network; Atmus will no longer accept paper invoices
- Header Level Credit Memos: Credit Memos applied against whole invoices; not accepted by Atmus
- Non-PO Invoices: Apply against a PO not received through Ariba Network
- **BPO Invoices:** Invoices against a blanket purchase order
- Services Invoices: Invoices that require service line item details
- Contract Invoices: Apply against contracts
- Line Level Credit Invoices/Credit Memos: Item level credits; price/quantity adjustments

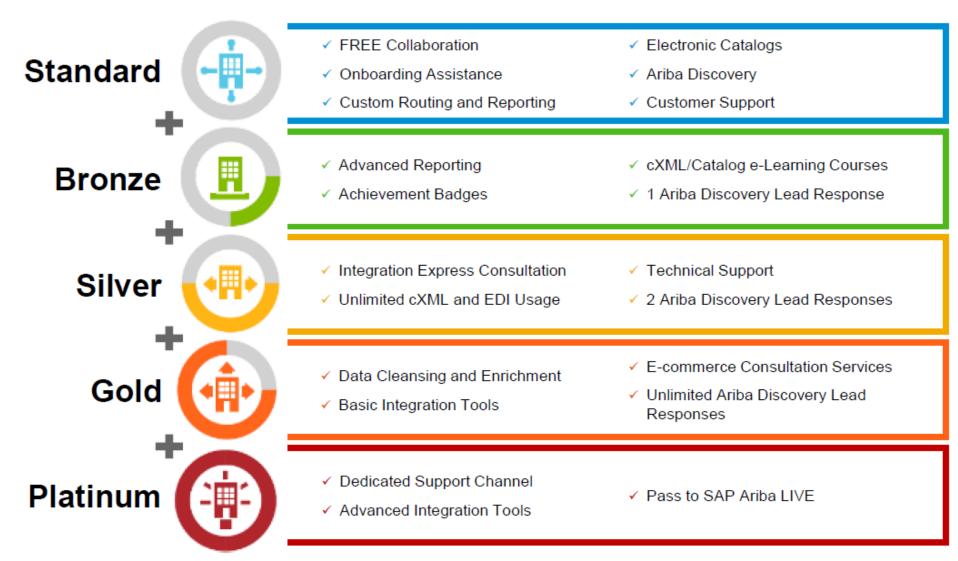
